

2010-OR- 3

An Ordinance Re-Districting the City of Jeffersonville
For Calendar Year 2010 and 2011

Whereas, beginning in 2007 the City of Jeffersonville, Indiana began the process of annexing certain areas contiguous to the city boundaries in existence at that time;

Whereas, a remonstrance was filed by some residents, litigation was initiated and the Indiana Supreme Court upheld the City of Jeffersonville's annexation in 2009;

Whereas, the annexation added a substantial area to the city limits as well as substantially increased the population. The population increase was such that the City Council passed an ordinance elevating the City from Class Three to Class Two status;

Whereas, Indiana law provides that, upon the passage of the ordinance elevating the City to Class Two status the City shall be considered a Class Two City for all matters except the political structure;

Whereas, Indiana statute provides that the City of Jeffersonville shall continue to have five (5) council districts with two (2) at-large members and a Clerk and Treasurer until noon on January 1, 2012;

Whereas, the United States Supreme Court and the Indiana Court have determined that it is necessary that council districts be organized such that the age-old democratic theory of "one man-one vote" be honored;

Whereas, in order to comply with the United States Constitution and the Indiana Supreme Court, the Jeffersonville City Council adopts the following councilmanic districts for the City of Jeffersonville. These districts shall remain in full force and effect until January 1, 2012 at which time the new government of the City of Jeffersonville shall take effect;

Therefore, be it ordained that:

The City of Jeffersonville shall be divided into the following Councilmanic Districts:

District One:

Precinct One, Two, Three, Four, Five and Seven. Councilman Mike Smith

District Two:

Precincts Fourteen, Fifteen, Sixteen, Sixteen "A", Twenty-Five, Utica Three, Utica Four, and Charlestown Seven. Councilman Edward Zastawny

District Three:

Precincts Nine, Nineteen, Twenty, Twenty One, Twenty Two, Twenty Three, and Utica 2. Councilman Keith Fetz

District Four:

Precincts Six, Eight, Twelve, Seventeen and Eighteen. Councilperson Connie Sellers

District Five:

Precincts Ten, Eleven, Eleven "A", Thirteen, and Twenty-Four. Councilperson Barbara Wilson


This Ordinance shall remain in full force and effect until that time when the City of Jeffersonville's government shall be conducted pursuant to those law of a Class Two city as adopted by the Indiana State legislature.

Severability Clause:

Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.


This Ordinance shall be in full force and effect upon its timely passage, promulgation and approval by the Mayor.

Passed and adopted by the Common Council of the City of Jeffersonville, Clark County, State of Indiana, this 1st day of February, 2010.






